

**The Fulham Shore plc**  
**("Fulham Shore" or "the Company")**

**Grant of options**

The Fulham Shore plc (AIM: FUL) announces that the Company has today granted 3,800,000 options over ordinary shares in the Company ("Ordinary Shares") to employees pursuant to The Fulham Shore Company Share Option Plan ("CSOP") and the Unapproved Share Option Scheme (together, the "Options"). The Options have an exercise price of 10.15 pence per Ordinary Share (being the mid-market price at midday today, Wednesday 25 July 2018).
